Change of number of shares and votes in Readly

The number of shares and votes in Readly International AB (publ) ("Readly" or the "Company") has changed as a result of exercise of warrants issued on 6 December 2017.

Through the subscription of shares through exercise of warrants, the number of outstanding shares and votes in the Company has increased by 240,000, from 36,791,448 to 37,031,448. Readly's registered share capital has increased by SEK 7,200, from SEK 1,103,743.44 to SEK 1,110,943.44.
